		Fully vaccinated	Incompletely vaccinated OR unvaccinated
<b>ISOLATION</b>  Because you're infected, regardless of vaccination status, you need to complete days in isolation.	<b>Positive Case - Asymptomatic, Mild, Moderate Symptoms</b>	10 days	
	<b>Positive Case with Severe &amp; critical symptoms</b>	21 days	
<b>QUARANTINE</b>  Yay for fully vaccinated - you can quarantine for shorter period!	<b>Close contacts and travelers</b>	7 days	14 days
